

PARISH SCHOOL TUITION AND FEES 2011-2012

The burden of maintaining St. Vincent de Paul Grade School is borne by the entire parish, with the parents/families of enrolled students assuming a portion of the educational costs incurred for the education of their child (ren). Tuition increases, as always, are based on the percentage increase in teachers' salaries.

In short, every student enrolled at St. Vincent de Paul Grade School is on a partial scholarship. For the 2011-2012 school year, the scholarships (savings to families by belonging to the parish) are as follows:

Non-Catholic/Non-Parish Affiliated tuition is \$4,000.00 per child

It is necessary that each family benefiting from the dedication of the parish-at-large be an active member of the Community through the sharing of talent and treasure. Since the scholarships (reduced Tuition) are a benefit of belonging to the Parish, it is understood that Sunday envelopes will be used regularly for the support of the Parish, according to the means of each family.

TUITION PAYMENTS

Tuition to St. Vincent de Paul Grade School may be paid in one of three (3) ways. These options pertain to both parish and out-of-parish families.

- A. One (1) annual payment of the entire tuition amount, due in August.
- B. Two (2) equal payments of half the tuition amount due in August and the first day of classes in January.
- C. Eleven equal payments through the Automatic Debit plan listed below.

Option C requires that Tuition payments are due on a monthly basis over an eleven (11) month period, beginning in July and ending in May. Payments are due on either the 3rd or the 17th of the month.

This Policy includes parish families who participate in the FACTS program. (see below, SPECIAL

ARRANGEMENTS)

Direct payment (Automatic Debit) is limited to Kindergarten through Eighth Grade.

OTHER SCHOOL FEES

Non-tuition School Fees must be paid separately, according to the following schedule.

ARREARAGES

Arrearages would only occur because of insufficient funds in an account.

1. Arrearages that exist at the time of report card distribution will withhold the report card from the student(s) and not allow a Parent/Teacher conference to be held.
2. Arrearages that exist at the change of semester or at the end of the school year will render the student(s) ineligible for enrollment for the second semester or next school year, respectively.
3. Repeated arrearages while participating in Option C may force a family to pay tuition according to Option A or B.

SPECIAL ARRANGEMENTS (FACTS)

FACTS – GRANT AND AID APPLICATION exists for the equitable assessment of parish families in particular need. Those parish families believing that their particular situation warrants a further reduction in tuition are free to apply through FACTS. The results of the FACTS findings will be reviewed by the Pastor of SVdP and a representative of the St. Vincent de Paul Finance Commission. Following the review, each applicant family will be notified of their applicable tuition reduction. The reduced tuition level is paid through the Automatic Debit system.
