I further realize and accept that:

1. Arrearages that exist at the time of report card distribution will withhold the report card from the student(s) and not allow a Parent/Teacher conference to be held.
2. Arrearages that exist at the change of semester or at the end of the school year will render the student(s) ineligible for enrollment for the second semester or next school year, respectively.
3. Repeated arrearages while participating in Option C may force a family to pay tuition according to Option A or B.
